1. Selection process will be through Screening cum Interview. The Department reserves the right to change/ modify the selection process at any time, during the process, at its discretion. The decision of the dept. will be final and binding.
2. Applicants are advised to ensure, before applying, that they possess the minimum essential qualification
3. *Candidates are advised to visit Inclusive Education Cell, Ground floor of Education Department Govt. of Sikkim, Tashiling, Gangtok with their documents on or before 13<sup>th</sup> June, 2025. (until 4.00pm).*
4. Application fee amounting to Rs. 200/- should be submitted through Revenue receipt and must be deposited under head 0202-01-101-03 (Elementary Education).
5. No TA/DA is admissible for attending the Screening cum Interview.
6. If, on verification at any stage of the examination, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post shall be cancelled by the Department without notice.

7. In case of any disputes that may occur in the process of selection, the decision of the Dept. shall be final and unquestionable.
8. The selected candidates shall be placed on probation for a period of two year and shall draw a consolidated pay equivalent to the prevailing norms.
9. The last date of submission of applications is **13<sup>th</sup> June 2025 (until 4.00pm)** Application submitted thereafter will not be accepted and Department shall not be responsible for the same.
